Leadership development - When Muslim women see others that look like them, then they realize they have to potential to pursue that role. "If I see it, I can be it." - Geena Davis. We strive to build a sisterhood, a network that provides personal, professional, and spiritual development to Muslim women in order to grow, contribute and participate in all sectors of society. RISE provides skill building workshops, trainings and events by leveraging local female scholars, professionals, and experts to provide skills based learning activities. In 2017, we hosted networking events, community conversations, and built a platform so Muslim women to connect to each other. We created a website, three social media accounts (Facebook page, Twitter, Instagram), and an email database. RISE also works to place Muslim women in positions of power by serving on boards, commissions, and grant committees. In March, 2017, RISE organized a sold-out leadership conference for Muslim women called Muslim Women Rising. Finally, Muslim sisters work hard, save money and are very charitable. Their faith influences their giving and the need to make the world a better place. Women are donors and are required by their faith to donate a percentage of their wealth back into their communities. Often they are very humble about their giving, and rarely ask what impact their money is making. So much that the

Storytelling - RISE is re-framing the Muslim women narrative by telling our stories ourselves. Our Muslim Sherheroes of Minnesota storytelling project is addressing the negative stereotypes around Muslim women by spotlighting change makers in our own communities that are having a social impact. Because public perception influences public policy. Six interview style articles have been written, six videos created and aired on Twin Cities Public Television, and six blogs curated from the community. These stories have had a global reach, videos and content going viral. We've also presented at the Minnesota Department of Health's annual conference about the project. 950,000 individuals benefited.

Civic Engagement - We work to increase civic engagement of Muslim women within their faith community, schools, cities, and at the state level. They are building relationships with elected officials, understanding the legislative process, taking a position on issues, and participating in democracy. We see women voting in non-presidential elections, visiting the Capitol and talking to their legislators on issues like gun violence, Minnesota family incentive program and building capacity for nonprofits led by communities of color. They are serving on boards, city commissions, and running for office.
